



TERMS & CONDITIONS OF EXHIBITING

Virtual Event May 7th 2021

CONTRACT FOR EXHIBITING

- Applications are processed on a case by case basis for companies with a good credit record with IPPN
- Applications for stand space at the Exhibition must be on IPPN's official Contract Form and must (if so required) contain information on all exhibits to be displayed. Until the completed Contract Form has been received and accepted by IPPN, IPPN has the right without giving notice to the Exhibitor to reallocate the stand space to another exhibitor and the application will be deemed to have been rejected.
- All payments must be made in accordance with the terms and methods of payments set out on the Contract Form.
- In the event the Exhibitor fails to meet any such payment obligations (whether as to the amounts or date of payment) IPPN reserves the right to cancel its contract with the Exhibitor and to resell or reallocate the stand space allocated to the Exhibitor.
- Exhibitor bookings can only be processed on receipt of payment.

REGULATIONS

- Compliance with Regulations - the Exhibitor shall abide by and observe all requirements, laws, rules and regulations whether imposed by IPPN, the proprietors or managers of the Exhibition or any other competent authority.
- If it appears to IPPN that the Exhibitor may be engaged in activities which are deemed to be contrary to the best interest of the Expo, it's attendees, staff; activities and products which appear unethical, in breach of the law, or contravening IPPN's ethos, mission and values; IPPN may without being under any liability to refund or abate any charges paid or due herein; cancel any stand space allocation which may have been made available/provided to the Exhibitor; require him forthwith to vacate the virtual booth allocated to them and refuse the Exhibitor the right to participate further in the Exhibition.
- IPPN is entitled to final approval of exhibitors and all aspects of their exhibits / sponsorship / advertising etc.
- Exhibitors may conduct giveaways from the confines of their own virtual booth, however IPPN will not announce winners or distribute prizes.



- If the virtual platform used for the purpose of the Virtual Exhibition hall becomes impossible because of a software or issue with the hosting platform or if the holding of the Exhibition or the performance of any of the provisions of this Agreement are interfered with by virtue of any cause, this Agreement and/or the Exhibition (or any part thereof), may forthwith be terminated or cancelled by IPPN without IPPN being liable in damages or otherwise to the Exhibitor.
- Virtual Booth Assignment - IPPN reserves the right to make final determination of all booth assignments. Virtual Exhibition booths will be allocated at IPPN's full discretion.
- No Assignment or "Subletting" of Space - The assigned booth space is for use by the Exhibitor only. The Exhibitor may not reassign this Agreement and may not permit or "sublet" all or any part of its assigned booth space to any other business or firm. Any such assignment, permission or "sublease" without IPPN's prior written approval shall be null and void.
- The Exhibitors are not permitted to give their assigned booth space either fully or in part to a third party, whether for payment or free of charge.
- Exhibitors may only use attendee contact information gathered at their own virtual stand.
- Harassment in any manner or form on the site, including via e-mail, chat, or by use of obscene or abusive language, is strictly forbidden.
- You agree that by submitting your information to us, you authorize us to contact you for advertising, marketing, reminders and other commercial purposes by email or SMS.
- In the event of cancellation of Exhibit Booth by the Exhibitor, IPPN shall determine a cancellation assessment charge covering prior services performed, and other damages related to said cancellation.
