This study has been funded by the Irish Research Council and it is a partnership between the University of Limerick and the Transgender Equality Network of Ireland (TENI).

What is this study about?

This study will:

- explore the experiences of transgender and gender-diverse children (children who reject traditional gender norms) and their families in negotiating everyday school life in primary schools
- Gain new insight into the experiences and approaches of primary school leaders and teachers in addressing the needs of transgender and gender-diverse students
- Map how gender identity and gender norms are understood and approached in the everyday of primary schools

What are you being invited to do?

You are being invited to participate in one interview of approximately one hour in length with the Principal Investigator of this study (details below).

Where will the research take place?

The research will take place in your school or at a location agreeable to you.

What are the benefits of the research?

There are no direct benefits to you. However, this project will:

- Be a ground-breaking piece of research from which TENI can advocate for change and future actions to address the needs of transgender and gender diverse young people in primary schools.
- Create groundwork for future work focusing on providing necessary professional development opportunities for pre-service and in-service school leaders/principals and teachers.

Are there any risks?

It is not envisioned that this study will pose any risk to you personally as it relates to your professional practice and your school. The support services of Catherine Cross, Education and Family Officer at TENI and/or Vanessa Lacey, Health and Education Manager at TENI will be available in the event that this interview causes upset. Both are qualified in counselling and support related to gender identity diversity.

What happens to the information?

You will be anonymous within the final report. All identifying information will be given different names.

What if I do not want to take part?

Participation is voluntary. If you agree to participate in this study, but later change your mind, you may withdraw at any time without giving a reason. If requested by you, all data collected will be deleted. If you wish to withdraw, please contact the Principal Investigator (details below).
